

**Travel Voucher Agreement and Release**

1. I understand that in order to receive a travel voucher, I must satisfy all requirements of the program and submit all required documentation. I understand that I am solely responsible for arranging transportation to and from the University of St. Thomas ("University"). I am also solely responsible for planning appropriately so that I have adequate time to catch any form of public transportation scheduled. The University is not responsible, in any way, for my transportation.

2. I understand that in order to participate in the travel voucher program, I must comply with all the rules and regulations of the University. Infraction of these rules may result in my being sent home immediately, at my own expense.

3. Travel by airplane, car, and other means entails certain risks. I understand these risks and I have adequate health insurance necessary to provide for and pay any medical costs that may directly or indirectly result from any injury I may sustain in travelling to and from and visiting the University. The University is not responsible for the cost of any medical care I may need while travelling to and from and visiting the University.

4. I (and my parent or guardian, if any), on behalf of myself, my personal representatives and my heirs, to the fullest extent permitted by law, hereby release, waive, discharge, hold harmless, defend and indemnify, and promise not to sue the University, its trustees, officers, employees, students, agents, other participants, sponsoring agencies, sponsors, and advertisers ("Releasees"), with respect to any and all harm, injury, disability, death, loss or damage to person or property, arising out of my visit to the University of St. Thomas and my travel to and from the University.

5. The laws of the State of Minnesota shall govern the validity, construction and enforceability of this Agreement and all suits, actions, claims and causes of action relating to the construction, validity, performance and enforcement of this Agreement shall be in the courts of the State of Minnesota.
