Aquinas Scholars Honors Program Internal Student Board Elections Updated 2/15/18

- 1. Aquinas Scholars Student Board Members who are not graduating and would like to remain on the student board will decide **one** position to run for. Board members will email a senior scholar of the executive board with their choice of position. In the email, the scholars may indicate two other positions they would like to run for so that secondary ballets can be printed.
- 2. Voting will take place at a student board meeting. Any scholars studying abroad may vote via email.
- 3. The senior member of the executive board will compile a ballot for the board to vote with, entering each board member only once. Each ballot will list only one position and the scholars running for that position.
- 4. When voting on a position, board members running will give a brief, one-minute, speech about why they would like to run for the respective position. If there is only one scholar running or less scholars than there are positions, the speeches may be skipped.
- 5. All student board members (seniors included) will vote on each position. They will get to vote between the scholar(s) running for the position or an option to keep the position open for a new scholar. The positions will be voted on in the following order:
 - a. Symposium Chairs (2)
 - b. Academic Chairs (2)
 - c. Service Chairs (3)
 - d. Social Chairs (3)
 - e. Social Media Chair
 - f. Publications Chair
 - g. Recruitment and Orientation Chair
 - h. Webmaster
 - i. Treasurer
 - i. Secretary
 - k. Vice-President
 - l. President
- 6. If no one runs for a certain position, that election will be skipped and returned to later.
- 7. Once the president is elected, everyone who was not voted into a position will be able to run for an empty position, working backwards (from the president to the symposium chairs).
- 8. The secondary ballots will be used for voting until each position is filled.
- 9. Open positions on the board will be opened up to the rest of the Aquinas Scholars Honors Program.
