ROLAND MINNERATH was ordained a priest in 1978. He served in the diplomatic service of the Holy See in Brazil, Germany, and the Secretariat of State, before being elected a professor at the Catholic Theological Faculty of the University of Strasbourg, where he taught history of ancient and medieval Christianity and relations between Church and state. In 2004 he was appointed archbishop of Dijon. He is a member of the Pontifical Academy of Social Sciences and a member of the International Commission for the theological dialogue between the Catholic Church and the Orthodox Church. His main publications are *Les chrétiens et le monde, 1^{er}–2^e siècle* (Paris: Gabalda, 1973); *De Jérusalem à Rome. Pierre et l'unité de l'Église apostolique* (Paris: Beauchesne, 1995); *L'Église catholique face aux États. Deux siècles de pratique concordataire (1801–2010)* (Paris: Le Cerf, 2012).

JEFFREY L. MORROW is associate professor at Seton Hall University's Immaculate Conception Seminary School of Theology, and is a senior fellow of the St. Paul Center for Biblical Theology.

SHANTHINI PILLAI is associate professor at the School of Language Studies and Linguistics, Faculty of Social Sciences and Humanities, National University of Malaysia (UKM). Her research interests are

anchored primarily in ethnic diversity, diaspora, and transnationalism in literary and cultural texts with particular reference to the global South Asian diaspora. She is author of *Colonial Visions, Post-colonial Revisions: Images of the Indian Diaspora of Malaysia* (2007), as well as numerous articles in various refereed and indexed journals of literary and transnational studies. She is also a recipient of the 2006–2007 Australia-Malaysia Institute Fellowship, as well as the 2013 Asia Research Institute Visiting Senior Fellowship.

ROBERT ST. HILAIRE is associate professor of religious studies at Niagara University. He received his ThD from Harvard Divinity School. His research interests include the thought of Thomas Aquinas and twentieth-century Thomism, especially early transcendental Thomism and *la nouvelle théologie*.

DEBORAH SAVAGE is a member of the faculty at the St. Paul Seminary School of Divinity at the University of St. Thomas in St. Paul, Minnesota, where she teaches philosophy and theology. She is a student of Aquinas with a particular interest in investigating his thought in light of contemporary questions. She is the cofounder of the Siena Symposium for Women, Family, and Culture, an interdisciplinary think tank organized to respond to Pope St. John Paul II's call for a new and explicitly Christian feminism. She is at work on a book tentatively entitled *Woman and Man* under consideration for Catholic University of America Press.

CAROLYN F. SCOTT is associate professor of English in the Department of Foreign Languages and Literature at the National Cheng Kung University in Taiwan. She is former chair of the Department of Humanities at the Pontifical College Josephinum in Columbus, Ohio. She received her MA and PhD from Indiana University, where her areas of specialization were Shakespeare, renaissance literature, and medieval studies. Recent publications include "Consuming Sorrow: Conversion and Consumption in *Tamburlaine; Part*

One” and “‘A sister calling:’ Intersubjectivity in Hopkins’ *The Wreck of the Deutschland*.”

THOMAS W. STANFORD III is associate professor and chairman of the department of English language and literature at Christendom College in Front Royal, Virginia. He received his doctorate from The Catholic University of America in Washington, DC. He was past editor of *Faith & Reason*, the academic journal of Christendom College.
